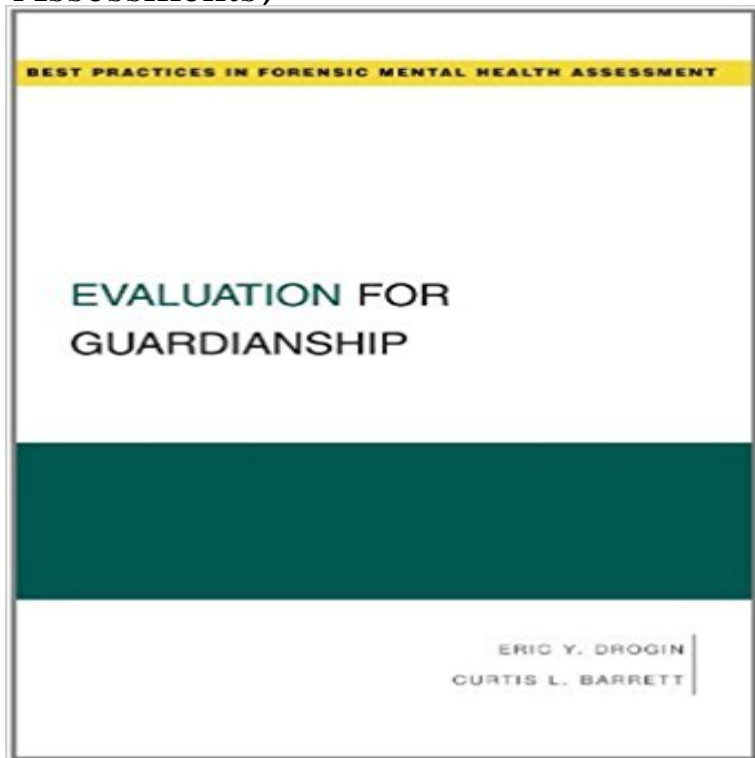


Evaluation for Guardianship (Best Practices for Forensic Mental Health Assessments)
